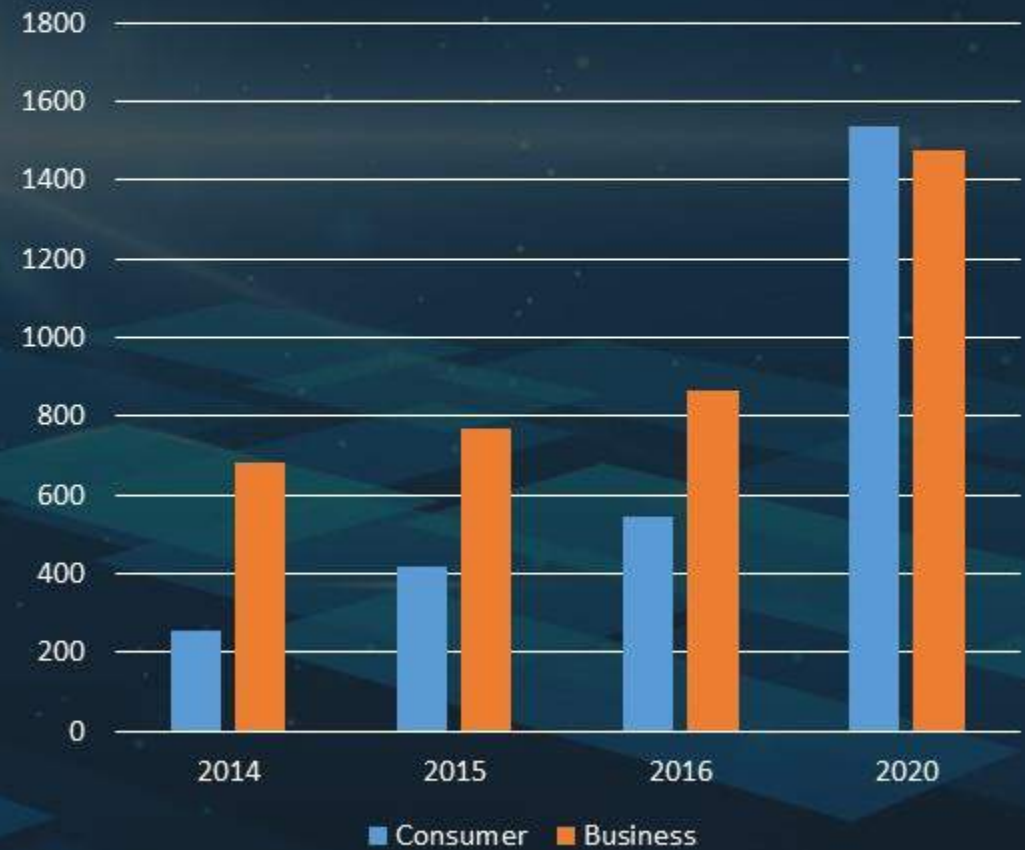


Market Validation

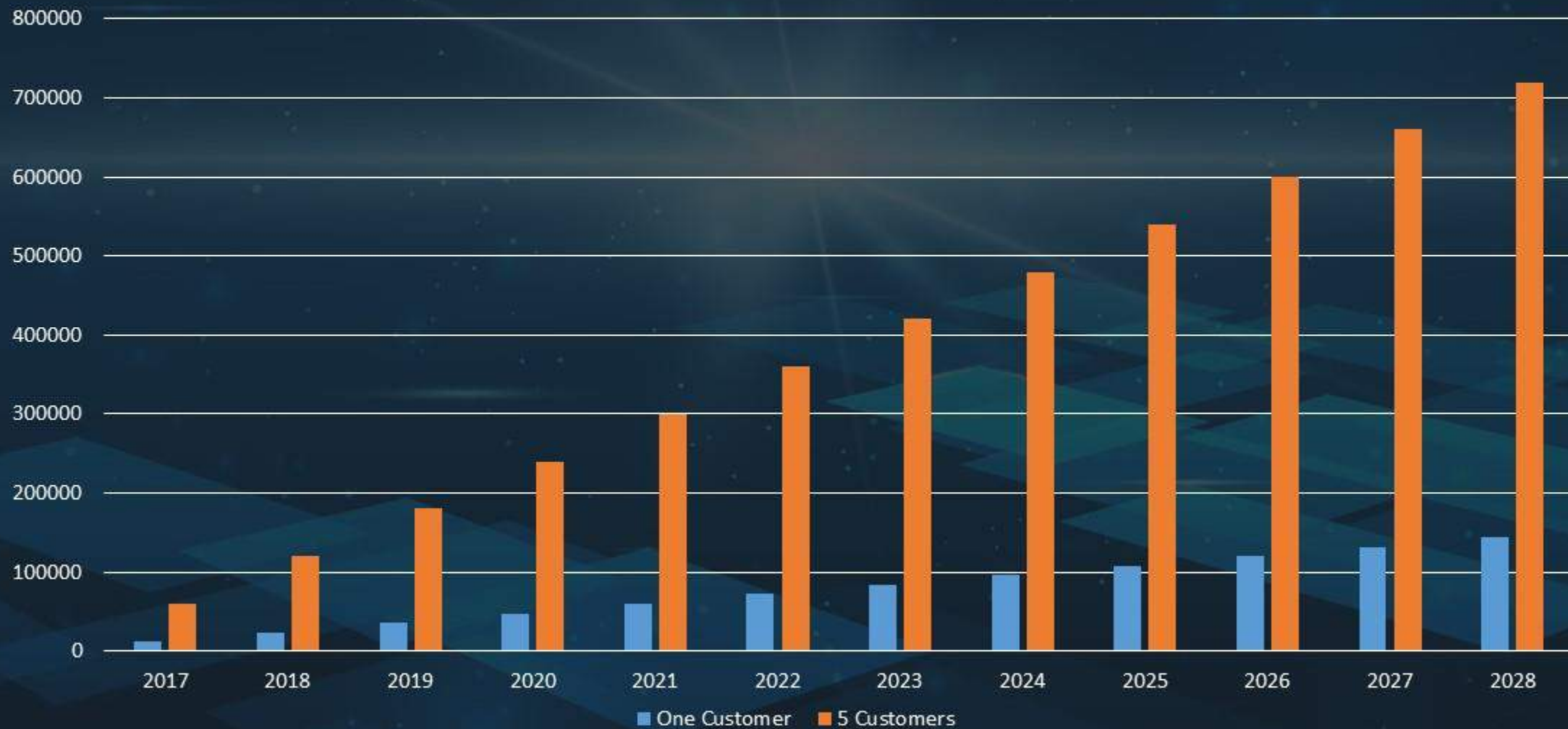
